Free School Meals

Dear Parents/Carers,

The Government is giving money to all schools to help pupils from lower income families do their very best. This funding is called the 'Pupil Premium'. We now receive this additional funding for each pupil on our roll registered as eligible for free school meals (FSM). This is currently £935 per pupil. We are using this money to help our pupils achieve the best possible grades in their GCSE examinations. Being eligible for a FSM clearly has a benefit to the pupil-namely, a free high quality meal. This saves parents/carers over £400 per year. Another benefit to the pupil is help with the costs of school trips.

We will provide £50 for students starting in Year 7 at King Charles I School in September 2019 who are eligible for free school meals. Applications can be made using the attached 'Uniform grant application form'.

We therefore strongly encourage eligible parents/carers to apply for this status. No one will know who has registered and it will not affect any other benefits being claimed. The eligibility criteria for free school meals have been changed. This letter explains the changes and how they might affect you.

What are the new eligibility criteria?

You can register your son/daughter for Free School Meals if you get any of these benefits:

- Universal Credit with an annual net earned income of no more than £7,400
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- Guarantee element of State Pension Credit
- Child Tax Credit, provided you are not entitled to Working Tax Credit** and have an annual income that does not exceed £16,190
- Working Tax Credit 'run-on'-the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit

Pupils can also register for Free School Meals if they get any of these benefits themselves.

I don't currently claim free school meals-what does this mean for me?

If you think you might be eligible for free school meals, submit an application form. The information you provide will be used to check if you are in receipt of a qualifying benefit and, if you are on Universal Credit, that your earnings do not exceed the threshold. If you claim Universal Credit, your earnings will be assessed from up to three of your last Universal Credit assessment periods. If you are eligible, we will be notified. Your son/daughter will receive free school meals and we will receive extra funding.

I am currently claiming free school meals-what does this mean for me?

Most people won't be affected by the new criteria. If you are currently claiming free school meals, but don't meet the new criteria, your son/daughter will continue to receive free school meals until the end of the Universal Credit rollout period. This will apply even if your earnings rise above the new threshold or if you stop being entitled to Universal Credit. The rollout period is currently scheduled to end in March 2022. Once Universal Credit is fully rolled out, your son/daughter will keep their free school meal until the end of their current phase of education (i.e. primary or secondary).

Before completing this application form, **please read the following notes.**

Privacy Notice

The information you provide will be used for administering Free School Meal applications, which are processed using an automated decision making tool. We will store this information for as long as you remain eligible plus 4 years, after which it will be securely disposed of. A full privacy notice detailing how we use your personal information in line with GDPR will be available on our website.

1. If you receive any of these benefits then you may be entitled to Free School Meals:
 - Universal Credit provided they have an annual net earned income not exceeding £7,400 (616.67 per month)
 - Income Support
 - Income-based Jobseeker's Allowance
 - Income-related Employment and Support Allowance
 - Support under Part 6 of the Immigration and Asylum Act 1999
 - The guarantee element of Pension Credit
 - Child Tax Credit, provided they are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190, as assessed by HMRC
 - Working Tax Credit **run-on**-paid for 4 weeks after you stop qualifying for Working Tax
2. You **MUST** provide all the information we have requested so that we can undertake a benefit check against the relevant benefit departments. **Please list all of your children on this form, even if they attend different schools.** If we cannot confirm your entitlement through this process we will contact you to provide paper proof of the benefit you receive.
3. If your child/ren are eligible to a free school meal they have the option of not taking this up but **every valid claim will assist your child/ren's school** as it enables them to access the governments pupil premium fund.
4. We will send written notification to you and your child/ren's school with the date the provision starts. The date of entitlement starts when we receive a valid application and the eligibility is confirmed. **Your claim cannot be backdated** and will be reviewed on a regular basis. We will **not** notify you on any applications made for Key stage 1 pupils qualifying under the Universal Infant Free School Meal provision. This detail will be held at the school.
5. Your child/ren will continue to receive Free School Meals until the end of the Universal Credit rollout period. This will apply even if your earnings rise above the new threshold or if you stop being entitled to Universal Credit. The rollout period is currently scheduled to end in March 2022. Once Universal Credit is fully rolled out, your child will keep their free school meal until the end of their current phase of education i.e. primary or secondary.
